Freedom Giving

What is Freedom Giving?

Freedom Giving (E-Tithing) is an automated giving program from Central Church that enables you to make tithes, offerings, and pledges to the church through electronic funds transfer (EFT).

Am I required to participate in this program?

No, making your contributions through EFT is completely voluntary. You may continue to place your contributions in the offering or mail them to the church office if you wish.

How can funds be withdrawn directly from my account?

Only with your authorization. No one can deduct money from your account unless you specifically authorize it.

When would this automatic contribution be taken from my account?

You can specify whether you want your contribution made weekly, semi-monthly or monthly.

Can I still contribute using cash or checks even if I enroll in Freedom Giving?

Yes, you can respond to special offerings or make additional contributions using a check or cash without affecting your regularly scheduled electronic contributions.

Is there a fee to participate in this program?

The church does not charge a fee and banks rarely charge fees for EFT.

How can I keep a record of the amount I have contributed?

Your contribution is made on a pre-established day, so you can deduct it from your records then. Your bank statement will include an itemized list of automatic deductions from your account. The church will continue to provide you with yearly offering statements.

Can I designate contributions to specific funds?

Yes, the Enrollment Form allows you to direct your gifts to specific funds.

What if I change banks or accounts or want to change the amount of my contribution?

Either notify the church Treasurer via email at msage@centralministries.com or simply fill out a new Enrollment Form and mark a "Change" box.

Is an electronic contribution risky?

No, it's safer than writing a check. It can't be lost, stolen, or destroyed in the mail. Plus, it has an extremely high rate of accuracy.

What if I want to cancel my electronic contribution?

Notify the church Treasurer in writing, allowing reasonable time to act on your request. A termination form will be provided to you upon request.
